


2013 Annual Giving Report

MISSION STATEMENT:


With a Christian focus, we will establish, sustain and strengthen programs and services that improve the quality of life, community and economy with an emphasis on West Michigan.

- Consistent with our mission, 95% of the \$2,646,200 distributed in 2013 stayed in West Michigan.
- Funding to the Grandville Avenue Initiative increased to \$425,000.
- There were seven first time recipients in 2013.
- A total of 85 organizations received funding in 2013.
